#### **Economic Development Director**

Michael Tardiff, Executive Director and Matt Monahan, Senior Planner from Central NH Regional Planning Commission (CNHRPC) were introduced. As previously discussed, the EDC is looking at the possibility of contracting with CNHRPC to fill the newly created Economic Development Director position.

Mr. Tardiff said the CNHRPC is excited to talk about this opportunity. With Mr. Monahan the lead person, they can also provide the expertise of other staff members and can be flexible with time.

Mr. Monahan outlined the strong connection between planning and economic development, the important of recruiting business and supporting and maintaining current businesses and assuring that the town's message is clear and shared.

There was further discussion between the committee and the guest including:

- The Contoocook Chamber of Commerce supports this plan.
- There is a state development strategy and a regional one, so the town needs to determine where its strategy matches these and where it can provide unique opportunities.
- When asked Mr. Monahan and Mr. Tardiff said the Mr. Monahan has the time capacity to do this work.
- Mr. Monahan has significant experience writing and administering grants.
- The Planning Board is currently reviewing the zoning ordinance looking at allowed uses and adding definitions with the plan to present the changes to Town Meeting in March. The Master Plan is currently being updated and is behind schedule.

After discussion, the EDC decided to recommend to the Select Board that the Town contract with CNHRPC to fill the Economic Development Director position.

It was noted that the Economic Development Committee will be presenting to Hopkinton Rotary tomorrow.
