APPROVAL OF MINUTES FROM FEBRUARY 8, 2021

FOLLOW-UP TO EDC VISIONING SESSION

The committee engaged in a visioning session, led by Meredith Lee, working to narrow down a tag line for Hopkinton. Based on past discussion, the board members in attendance unanimously agreed on the tagline "Two Villages, One Heart. Opportunity Grows Here." The group would like input from other members of the Economic Development Committee at a future meeting, at which point a vote will be taken to officially approve the tagline.

ECONOMIC STRATEGIC PLAN

Mr. Monahan led the committee in a discussion of the Economic Development Strategic Plan. The group discussed ways to promote Hopkinton's tax incentives, including 79-E and the ERZs. One thought is to reach out to the recipient(s) of 79-E for a testimonial (once the assessments have been done and tax bills are sent out - around July). Group agreed to revisit the Strategic Plan at least quarterly and adjust as needed.

NEW BUSINESS

Mr. Whitley informed the group the Public hearing notice for the 202/9-Maple Street Intersection on March 25, 2021. It is an opportunity to provide feedback to DOT about their planning process. MR. Monahan will follow up with his colleagues to determine if a buildout analysis will be prepared before that meeting.

UPDATES

Updates from Matt Monahan

- 1. Economic Development Chapter for Master Plan
 - a. Mr. Monahan will send the group a draft for review and that will be on the agenda for next meeting.

- 2. TIF District Board
 - a. Mr. Monahan reported he is working on reaching out to people to join the TIF board.
- 3. ERZ Letters
 - a. Letters have been sent to landowners in the ERZ districts.
- 4. Website Update
 - a. Website has been updated so that there is a "Tax Incentives for Businesses" page on the Town of Hopkinton's website.

Land Swap

The land swap is not quite completed. All documents are finalized, just waiting on the state to set/agree on a closing date.
