## FOLLOWUP TO EDC VISIONING SESSION

This has been tabled until a future meeting with more members present.

### ECONOMIC DIRECTOR UPDATES

Reached out to engineer re: water and sewer study, awaiting response.

- Will receive SEO information to update the website to help drive web traffic.
- Mr. Whitley suggested Mr. Monahan connect with Mr Sagris or Ms Lee as connections with the Chamber of Commerce, Mr Whitley suggested Ken Traum and Billy Chapin as connections to the Rotary.
- Has had a new map built out of the villages and town as a whole to show potential build-outs and opportunities for growth. This map will be sent to the DOT for the Interstate 202 road changes/development.
- Looking at grant or bill funding opportunities regarding a potential federal-level infrastructure project that align with the strategic plan. Mr. Whitley suggested looking at bridge (specifically Tyler Bridge) and culvert repair and replacement. Mr. Fredyma suggested the high need for road rehab projects. All of these infrastructure items would support future economic development. Mr. Fredyma also suggested looking at Route 202/9 rotary intersection or overpass option we could also include Henniker in this option. Mr. Monahan also suggested including the intersection of 202 and 103. After looking at these options, members present agreed that:
  - The route 202/9 intersection is the most important project due to volume of use and safety concerns.
  - The second priority would be the roads rehab of Contoocook Village including drainage, paving, culverts, bridges, etc.

• After further discussion, members present decided to pass this to the Select Board for further input as to infrastructure priorities. Mr Whitley will also connect Mr Monahan with Dan Blanchette of the Hopkinton Roads Dept.

## MASTER PLAN EDC CHAPTER UPDATE

- Presented to the Planning Board with the EDC chapter of the strategic plan (transportation and economic development). Mr Monahan reports this presentation went well. Ms Wells estimates that by end or summer or early fall the chapters will go to public presentation and the Master Plan update will be completed.
- TIFF District Board Update: Mr. Monahan will continue to reach out to businesses within the district to increase this Board.

## UPDATES FROM THE COMMITTEE

- The land swap in West Hopkinton is complete.
- Ms Wells brought up the possibility of an opportunity for the Economic Development Committee to be in support of or connected with the End of Summer Concert Series as a way to publicize the ongoing work - and existence of - this committee. This will be discussed again at a future meeting.
- Mr. Whitley suggested this committee look to add committee members.
