Hopkinton Human Services Advisory Committee September 14, 2021

Present: Allita Paine, chair; Pam Manus, Nan McNicholas, and Dawn Berry

Town Administer Neal Cass joined our meeting to respond to questions the Advisory Committee had regarding the Job Description of the Coordinator Human Services. He told us that Alicia Presti has been employed as the new Coordinator of Human Services. She has a Bachelors Degree in psychology and a Masters Degree and has had ample experience in coordinating human services. It is planned for her office to be at the Slusser Center where she will have closer proximity to interactions with Hopkinton residents utilizing the facility.

During the interim, Neal Cass has handled the welfare cases until the new Director starts on September 20, 2021. We thanked Neal for his work and he returned to his office.

The minutes of the August 3, 2021 meeting were approved.

Two members of Dial a Ride expressed a need to form a Town Respite Committee that would provide a couple hours, without cost, for a care-giver to have a break. The liability for providing in-home respite was discussed. Different medical issues that could put a respite worker or client at risk were also discussed. The committee will suggest that the Dial a Ride group do a survey of volunteers and clients to assess need and willing volunteers to be a respite provider. Then, they could draft a proposal for respite service with an understanding of liability and limits.
