CALL TO ORDER

The Select Board reviewed the information received from Town Counsel and from Primex concerning the purchase of land by the Conservation Commission currently owned by the Chesley's.

Town Counsel has said that the Conservation Commission does have the authority under RSA 36-A:4 to acquire in the name of the city or town, subject to the approval of the local governing body, by purchase, the fee in such land or water rights within the boundaries of the municipality, or any lesser interest, development right, easement, covenant, or other contractual right including conveyances with conditions, limitations, or reversions, as may be necessary to acquire, maintain, improve, protect, or limit the future use of or otherwise conserve and properly utilize open spaces and other land and water areas within their city or town, and shall manage and control the same..." so they can purchase the property with Select Board approval with the condition that the farmers currently farming a small portion of the property may continue to do so for up to 5 years. This is not a lease, but a condition of sale.

Discussion took place as to the requirement of liability insurance for the farmers. It was noted that all people who are given exclusive use for a period of time of town property are required to have liability insurance naming the Town as additional insured. After further discussion, it was agreed that the Conservation Commission will assure that appropriate liability insurance is in place as part of their responsibility to manage the property.

Mr. Whitley moved that the Select Board approve the purchase of property by the Conservation Commission from Cathy and Earle Chesley subject to the conditions of sale that the farmers currently farmer the land can continue for up to 5 years, and Bohanan Farm will be allowed to continue haying the property at the discretion of the Conservation Commission. Ms. Wells seconded the motion
