# CALL TO ORDER

Select Board Chair Jim O'Brien called this regular meeting of the Select Board to order at 5:30 p.m. on Tuesday, December 26, 2017, in the large meeting room in the Town Hall. Mr. O'Brien introduced the members of the Board. Sabrina Dunlap led those assembled in the Pledge of Allegiance.

#### **Approval of Minutes**

The Board reviewed the minutes of their previous meeting. Mr. Traum made a motion, seconded by Mr. Lux, to approve the Select Board Public Meeting Minutes of December 11, 2017. Chair O'Brien called for a vote.

**VOTE:** O'Brien, Traum, Lux and Gerseny, voting in favor of the motion; no votes against; Dunlap abstained. MOTION APPROVED 4-0-1

#### **Actual 2017 Expense Review**

Mr. Cass reviewed the year-to-date budget numbers. He reminded the Board that there is still another week left in the year and the payroll for that week includes the Christmas Holiday with storm overtime. The numbers look very good. Both the Board and the Town Administrator expressed appreciation to the Department Heads for their excellent work managing their budgets.

#### 2017 Encumbrances

The Board reviewed two encumbrances and approved the following to be encumbered from the 2017 Operating Budget to be expended in 2018:

- 1. \$10,000 to Arnett Development Group, LLC to complete the Development Potential Analysis.
- 2. \$11,500 to Hoyle, Tanner & Associated, Inc from work on the Build-out/Cost Analysis and Conceptual Sewer and Water Extension along Maple Street.

#### **Other Items**

Mr. Traum said that the School Board will be meeting on January 2, 2017 to finalize their budget and determine what will be part of the facilities bond request. They will be presenting to the Budget Committee on January 10.

Mr. Cass noted that about 70 children were part of Operation Christmas coordinated by Marilyn Ceriello Bresaw. She is to be commended for her effort and work on this.

There have been questions about the prepayment of taxes. The Select Board voted on February 8, 2016 to reaffirm its previous vote to accept the prepayment of taxes following the terms of NH RSA 80:52-a. This allows prepayment up to two years in advance.

#### NON-PUBLIC SESSION IV-RSA 91-A: 3 IV (e) Legal

Mr. Traum moved to go into a non-public session regarding a legal issue under the provisions of Nonpublic Session RSA 91-A: 3 II (e). Mr. Lux seconded the motion.

**VOTE:** Select Board Members Traum, Lux, Gerseny, Dunlap, and Chair O'Brien voted in favor, and the Chair declared the motion to have carried unanimously (5–0).

The Board and Town Administrator went into nonpublic session, as recorded separately, at 5:43 p.m. The Board returned to public session at 5:54 p.m.

These minutes were not sealed.

#### ADJOURNMENT

There being no further business, motion by Mr. Traum, seconded by Mrs. Dunlap to adjourn the meeting. Vote 5-0 in favor of the motion. The meeting adjourned at 5:55 p.m.
