SELECT BOARD PUBLIC MEETING MINUTES MONDAY, MAY 15, 2017

CALL TO ORDER

Chairman Jim O'Brien called this regular meeting of the Select Board to order at 5:30 p.m. on Monday, May 15, 2017, in the large meeting room in the Town Hall. Chairman O'Brien introduced the members of the Board. Ken Traum led those assembled in the Pledge of Allegiance.

The Board reviewed the Select Board Meeting Minutes of Monday, May 8, 2017. Mr. Traum made a motion, seconded by Mr. Gerseny, to approve the Public Meeting Minutes of May 8, 2017. Chair O'Brien called for a vote.

VOTE: O'Brien, Traum, Gerseny and Dunlap voting in favor of the motion; no votes against. MOTION APPROVED 4-0.

The Board reviewed the Select Board Public Minutes of Thursday, May 11, 2017. Mr. Traum made a motion, seconded by Mr. Gerseny, to approve the Public Meeting Minutes of May 11, 2017. Chair O'Brien called for a vote.

VOTE: O'Brien, Traum, Gerseny and Dunlap voting in favor of the motion; no votes against. MOTION APPROVED 4-0.

APPOINTMENTS: There were no appointments.

OLD BUSINESS:

i. 2017-2018 Health Insurance: Mr. Cass presented the options for health care. After a lengthy discussion, which included cost of the plan for employees, and the pros and cons of each option, including the insurance that the Hopkinton teachers will be on beginning July 1. The Board made the decision to stay with the plans the employees currently have, with a 90/10 split as discussed at Town Meeting. There will be education sessions held during the year, with regards to the plan that the Hopkinton teachers will be on and the options will be revisited next year. Chairman O'Brien thanked Mr. Cass for all his work in preparing the options available.

NEW BUSINESS:

i. Review of financials through April: Mr. Cass stated the revenues look good, as well as the expenses. Motor vehicle revenue is on target.

Mr. Traum stated that he now remembers why they did not go to a fiscal year budget; the work involved in putting together an 18 month budget is tremendous.

TOWN ADMINISTRATOR UPDATES:

Mr. Cass stated he met with a resident with regards to the dog park. She thought the park would be abutting her property which is fenced in for her dog. She was under the impression that the fence for the dog park would be very close to her fence. It is not. She does not have an issue with the dog park.

Mr. Cass stated that we will begin the job of preparing the property documents for scanning with New England Documents.

Mr. Cass stated that the Hopkinton Fair has contacted him. They stated that Mondays are their meeting day as well as the Select Board's and they are not available on Mondays. Mr. Cass will try to schedule a time to meet on a Thursday, after one of the Select Board tours of the town buildings.

There being no further business, a motion by Mr. Traum, and seconded by Mr. Gerseny to adjourn the meeting. Vote 4-0 in favor of the motion. The meeting adjourned at 7:05 pm.
