# SELECT BOARD PUBLIC MEETING MINUTES Monday, March 14, 2022 Approved

#### **OLD BUSINESS:**

In reviewing some details of Town Meeting, Mr. Cass noted that there was a problem with the sound portion of Zoom. There was a brief discussion among Mr. Cass, Mr. Traum, and Mr. Whitley regarding presentation of tax information, and Mr. Traum noted that there may possibly be some changes with budget presentation at future Town Meetings. Regarding the Houston Barn, Mr. Cass said the Houston Barn Committee would be working on Requests for Proposals (RFPs) and Requests for Quotes (RFQs). He noted that the lot donated for the Town to sell is ready to go, that there will be more information to come on the solar farm, and that he will reach out to other towns for samples of Class VI road reclassification information.

#### **NEW BUSINESS:**

Regarding 2022 Board assignments for Select Board members, in addition to the Chair and Vice Chair of Select Board (Sabrina Dunlap and Ken Traum, respectively), the following assignments were discussed and decided: Budget Committee, Ken Traum; Planning Board, to be determined, but tentatively, Thomas Lipoma; Economic Development Committee (EDC), Steven Whitley; Open Space Committee, Sabrina Dunlap; Waste Reduction Committee, Jeffrey Donohoe; Road Committee, Steven Whitley; and Sewer Committee has been eliminated.

The 2022 Board, Committee, and Commission appointments were discussed, as well. While some people will continue in appointed roles, there will be contact with others to determine all 2022 appointments. Two confirmed reappointments are Ron Klemarczyk for the Conservation Commission and Dijit Taylor for the Open Space Committee.

#### **TOWN ADMINISTRATOR UPDATES:**

Mr. Cass said he was pleased with Town Meeting and will now be able to move on to other projects, such as the Horseshoe Tavern and the sale of the property donated to the Town. He, Mr. Donohoe, and Mr. Whitley discussed some details of the sale, and Mr. Donohoe suggested some guidelines for terms of the sale, such as cash only, no contingencies, limiting the time for offer acceptance, and closing in a short time. Mr. Cass said he would bring paperwork to the next scheduled Select Board meeting.

#### **OTHER:**

Mr. Whitley asked if there has been any update on the Horseshoe Tavern property and Mr. Cass said another surveyor will be hired.
