Description of matters discussed and final decisions made:

The Board discussed the Letter of Intent concerning GraniteApollo working to put a solar array on the town land by the Transfer Station. Discussion centered around the Town of Webster's role in the process now and moving forward. Mr. O'Brien and Mr. Traum agreed to meet with the Webster Select Board. The Town Administrator will set up the meeting with Webster and will contact Town Counsel concerning the issue.

Vote of Adopt Letter of Intent

Mr. Whitley moved to adopt the Letter of Intent (LOI) with GraniteApollo as presented at the meeting and further to authorize Select Board Chair Jim O'Brien to sign the letter on the Board's behalf. Ms. Dunlap seconded the motion.

VOTE: Select Board Members O'Brien, Traum, Dunlap, and Whitley voted in favor, and the Vice Chair declared the motion to have carried.

In the event of such circumstances, information may be withheld until, in the opinion of a majority of members, the aforesaid circumstances no longer apply.*
