SELECT BOARD PUBLIC MEETING MINUTES MONDAY, MARCH 18, 2019 Approved April 1, 2019

CALL TO ORDER

Town Administrator Neal Cass called this regular meeting of the Select Board to order at 7:00 p.m. on Monday, March 18, 2019, in the large meeting room in the Town Hall.

OLD BUSINESS:

Town Meeting: Overall Review of the Meeting: Mr. Whitley stated our budget was passed and we received directions on how to handle the Bates Building. Mr. Cass stated he will start the process of cleaning out the Bates Building. He also reminded the Board they will have to go through the subdivision process with the Planning Board.

Discussion ensued, with regards to making accommodations for the Supervisors of the Checklist to be moved to the Town Hall, at a time that is convenient for the Supervisors. Mr. Cass reminded the Board we need to look into appointing a Deputy Town Clerk and a Deputy Treasurer.

Ms. Dunlap stated that Mr. Traum and Ms. Persechino did an excellent job at Town Meeting, however, she noted that it was a low turnout, about 7% of the voters. She feels it is hard for

residents with back to back Saturday meetings. It was noted that the School District has no flexibility on their Annual Meeting time.

Ms. Dunlap informed the Board that she would not be available for meetings during the month of April, due to a family illness.

NON-PUBLIC SESSION I-RSA 91-A: 3 III (c) Reputation

Mr. Traum moved to go into a non-public session to discuss an issue which could affect the reputation of someone other than a Board member under the provisions of Nonpublic Session RSA 91-A: 3 II (c). Mr. Whitley seconded the motion.

VOTE: Select Board Members O'Brien, Traum, Dunlap, Whitley, and Wells voted in favor, and the Chair declared the motion to have carried unanimously (5–0).

The Board, a property owner, and the Town Administrator went into nonpublic session, as recorded separately, at 7:31 p.m. The Board returned to public session at 7:58 p.m.

Vote to seal nonpublic minutes:

Mr. Whitley moved to seal the minutes of the just completed nonpublic session because it was determined that divulgence of this information likely would affect adversely the reputation of any person other than a member of this board. Mr. Traum seconded the motion.

VOTE: Select Board Members O'Brien, Traum, Dunlap, Whitley, and Wells voted in favor, and the Chair declared the motion to have carried unanimously (5–0).

ADJOURNMENT

There being no further business, Mrs. Dunlap moved to adjourn the meeting. Mr. Whitley seconded the motion. All voted in favor and the meeting adjourned at 7:59 p.m.
