## **APPROVAL OF MINUTES OF January 12, 2022**

Ken Traum motioned, to approve the Draft January 12, 2022 meeting minutes. Norm Goupil seconded the motion. Mark Zankel asked for any clarifications or corrections. There were none.

The vote passed 10-0.

Ken Traum reported on each of the Warrant Articles stating that there are no major differences to report other than what was given at the January 12, 2022 meeting. He proceeded to read each Article. Mark Zankel asked for any questions regarding the Articles. There were none.

Mark Zankel stated that this is the opportunity to ask questions as we will be voting this evening on all Articles for all of the budgets as noted in Item 7 of the agenda. Mark Zankel thanked Ken Traum and Neal Cass for the presentation.

#### **HOPKINTON SCHOOL DISTRICT BUDGET – Norm Goupil and Michael Flynn**

Norm Goupil began by thanking the many persons who contributed to preparing the budget. He introduced Michael Flynn, Superintendent of Schools, who will answer questions posed by the Budget Committee at the meeting of January 12, 2022 relating to the budget presented at that time.

Michael Flynn reviewed his goals for the District stating that over this past year it was a reevaluation of what we budget and how can we do better. He provided examples of spending and how it affected the budget. He then moved on to the questions which were presented by the Budget Committee at the last meeting.

The first question was in regard to the proposed Food Service budget. Michael Flynn explained how the process goal is to eliminate the fund balance noting that this cannot be done all at once. He proceeded to review the Food Service Analysis which had been provided to the members.

Michael Flynn and Norm Goupil along with Michelle Clark proceeded to answer questions from the members. It was stated that the previous administration had always relied on fund balance to cover costs for food service. The reason for the \$1 in the line item was to transfer from general fund into the fund balance. Without the \$1 we would not be able to transfer the funds. Michelle Clark stated that budget transfers go to the Board, that is how those transfers covered the food service.

Michael Flynn then reviewed the Estimated Revenue and Expenses Food Service spreadsheet pointing out the deficit line. He stated that if our goal is to budget for what we ask for, we now have to budget for the deficit of food service because it is our goal to come to where we will not depend on the fund balance to cover that cost.

Michael Flynn stated it was discussed by the School Board to eliminate the fund balance in one year and it was agreed that was not a smart move. We are attempting to do that over 2 to 3 years. This is a calculated slow risk with a small chunk this year and then next year we may know better and budget accordingly. He stated that it is protection with appropriate forecasting that needs to be done.

The discussion continued and answer and questions session was held on the remaining questions of the Budget Committee that were made during the last meeting regarding programmatic budget, ESSR funds, and tax impact.

Michael Flynn then started his review of the Warrant Articles, reading each aloud and allowing time for questions and answer session. A brief discussion was held of the Articles and addressed by Michael Flynn and Norm Goupil.

Following the review of Articles, Jonathan Cohen commented his support of the lawsuit to get the State to more adequately fund towns. He stated that there is not adequate funding and that causes a strain on the town.

Deb Norris expressed her support as well.

Following discussion it was agreed that a statement regarding the law suit would be made as a separate item introduced by the Budget Committee at Public Hearing.

Mark Zankel asked if there were any further questions regarding the Warrant Articles of the Hopkinton School District. There were none.

#### **PUBLIC COMMENT**

Mark Zankel opened up Public Comment session. One person in attendance.

Loren Clement, 86 Maple Street, Contoocook, NH asked for clarification on the trust fund warrant article. He asked if the idea is to be one time funded. As the goal is to bring fund balance down, where will the money for it come from next year?

Michael Flynn added that at end of this year it may be needed to ask the voters for more money to fund this next year.

Loren Clement stated he is trying to understand the differences between the food service deficit and the fund balance and the trusts. He stated it is like shuffling.

Michael Flynn explained it is more shifting of the money. The money is there just shifting to where it needs to be spent.

Loren Clement stated in reference to the Restricted Fund Balance that was noted in one document presented, is there ever anything there. Michelle Clark stated that if we needed to reserve monies for legal that is where that would go.

Mark Zankel asked for any comments from those in attendance on line or via zoom.

Deb Norris thanked the School District for the work done and the way it was laid out. It was very clear. She stated it was appreciated for all the work done on it. Michel Flynn especially thanked Michelle Clark for all of her work.

Mark Zankel closed the public comment session.

# BUDGET COMMITTEE DELIBERATION ON PROPOSED OPERATING BUDGETS AND WARRANT ARTICLES TO PRESENT AT 2/9/22 PUBLIC HEARING

Mark Zankel explained that it is the Budget Committee's task to convene and lead a Public Hearing on the Drafted Proposed Budgets and Budget related Warrant Articles, which will take place on Wednesday, February 9, 2022. It is the responsibility of the Budget Committee to determine which Budgets they will recommend. The Budgets will be presented to the Budget Committee and voted on one-by-one.

## **TOWN BUDGET**

Ken Traum read Article 5: Operating Budget (Ken noted that Article V is the only article needing a vote) A brief discussion was held.

Ken Traum made a motion that the Budget Committee approve Warrant Article #5 for the Operating Budget of \$8,283,514. Don Houston seconded the motion. Mark Zankel asked for any discussion.

It was noted that this Article does not include appropriations contained in special or individual articles addressed separately.

Discussion followed on the air conditioning study conducted at Hopkinton Middle High School. Rich Houston stated that the study is available that outlines the different options and costs and he will email the results to each of the members of the Budget Committee.
