SELECT BOARD PUBLIC MEETING MINUTES MONDAY, FEBRUARY 6, 2017

CALL TO ORDER

Select Board Chair Jim O'Brien called this regular meeting of the Select Board to order at 5:30 p.m. on Monday, February 6, 2017, in the large meeting room in the Town Hall. Mr. O'Brien introduced the members of the Board. Steve Lux, Jr. led those assembled in the Pledge of Allegiance.

POINTS OF PRIDE

Mr. Cass stated this office answers many questions in regards to residents, and properties in town and that we rely on Karen Robertson's institutional knowledge. The Board reviewed the Select Board Meeting Minutes of Monday, January 23, 2017. Mr. Traum made a motion, seconded by Mr. Lux, to approve the Public Meeting Minutes of January 23, 2017. Chair O'Brien called for a vote.

VOTE: O'Brien, Traum, Strickford, Lux and Gerseny voting in favor of the motion; no votes against. MOTION APPROVED 5-0.

APPOINTMENTS: Tax Collector/Town Clerk, Chuck Gangel.

NON-PUBLIC SESSION IV-RSA 91-A: 3 IV (b) Hiring

Mr. Traum moved to go into a non-public session regarding hiring a person as a public employee under the provisions of Nonpublic Session RSA 91-A: 3 II (b). Mrs. Strickford seconded the motion.

VOTE: Select Board Members Traum, Strickford, Lux, Gerseny, and Chair O'Brien voted in favor, and the Chair declared the motion to have carried unanimously (5–0).

The Board, the Town Clerk/Tax Collector, and the Town Administrator went into nonpublic The session, as recorded separately, at 5:35 p.m. The Board returned to public session at 5:41 p.m.

The minutes of this session were not sealed.

Mr. Gangel informed the Board that the State has limited hours for more vehicle registration for the time period of February 13, 2017 to February 16, 2017; there will be no DMV transactions done after 4:30 pm. Also February 17, 2017 to February 21, 2017; there will be no registration at all on those days. This is due to the State installing a new computer system. The State has done press releases and Mr. Gangel will post a notice in the newspaper. This affects all towns in New Hampshire.

OLD BUSINESS: Approval and Vote on 2017 Town Meeting Warrant:

The Board voted on the Articles 3-10 as follows:

- Article 3: Operating Budget recommended 5-0
- Article 4: Appropriation to Capital Reserve Fund recommended 5-0
- Article 5: Appropriation to Expendable Trust Fund recommended 5-0
- Article 6: Digitalization of Town Records recommended 5-0
- Article 7: Authorization to Expend from Pay-by-Bag Special Revenue recommended 5-0
- Article 8: Rescind Pay-by-Bag not recommended 4-1
- Article 9: Authorization to Expend from Senior Center Rental Special Revenue Fund recommended 5-0
- Article 10: Discontinue the Expansion of the Highway Garage Capital Reserve Fund Recommended 5-0

PARK AVENUE FIELD SIGN PROPOSAL: Mr. Cass stated that Paula Simpkins, Recreation Director, recommends a sign with a removable section underneath that would display a sponsor area that would read "field sponsored by (company name). Mrs. Simpkins recommended seeking out bids for field sponsorship, bids starting at \$1,500.00, for a sponsorship lasting 3 years. Mr. Traum inquired about a timeline for the sign. Mr. Cass replied they would like to get to work on it, so that it will be ready for spring.

APPOINTMENTS: Cameron Ford re: Veteran's Tax Credit Expansion
David Luneau also joined Mr. Ford. Mr. Ford is in to see if the Board will reconsider and add a
Warrant Article with regards to the expanded Veteran's Tax Credit. The new veteran's credit
allows all veteran's that served at least 90 days and received an honorable discharge, to be
eligible for the credit. Currently, only those veterans who served during "qualifying events" and
certain dates within the qualifying events are eligible. David Luneau also spoke in favor of the
expanded veteran's credit. Discussion ensued, and there were not enough Board members in
favor of this change to get it on the ballot. However, Mr. Ford stated that he will be getting
signatures and it will be brought forward by a citizen petition. As this will be a new article, the
Board will be meeting on Wednesday, February 8, 2017 at 6:00 pm (at the High School, before
the Budget Public hearing) to vote to either recommend or not recommend the warrant article.

NEW BUSINESS: Public Budget Hearing on Wednesday, February 8, 2017

Mr. Traum will be presenting the town budget. The hearing will be held at the High School at 6:30 pm.

Dilapidated Building: Mr. Cass stated the home at 179 Pamela Drive is condemned and needs to be removed. He would like the Board to sign an order to have the home removed due to a severe health hazard, a flea infestation. Mr. Gerseny made a motion to sign the order to remove the home. Mr. Traum seconded the motion.

VOTE: O'Brien, Traum, Strickford, Lux and Gerseny voting in favor of the motion; no votes against. MOTION PASSED, 5-0.

Ordinance Update: Mr. Cass stated that he has been working with Dan Blanchette, Director of Public Works and Police Chief Steve Pecora on two separate ordinances, a speed ordinance and a parking ordinance, dealing with overnight parking.

TOWN ADMINISTRATOR UPDATES

Mr. Cass stated he has met with Department Heads to go over employee evaluations.

Mr. Cass informed the Board that the Hazardous Mitigation Plan has been approved by FEMA.

Mr. Cass informed the Board that he is still working with the Hopkinton Fair Board in regards to having Hopkinton residents on the Fair Board.

Mr. Cass reminded the Board that the Dedication for the Town Report still needs to be done.

VOTE: Select Board Members O'Brien, Traum, Strickford, Lux, and Gerseny voted in favor, and the Chair declared the motion to have carried unanimously (5–0).

The Board and the Town Administrator went into nonpublic session, as recorded separately, at 6:52 p.m. The Board returned to public session at 7:10 p.m.

Vote to seal nonpublic minutes:

Mr. Gerseny moved to seal the minutes of the just completed nonpublic session. Mrs. Strickford seconded the motion.

VOTE: Select Board Members O'Brien, Traum, Strickford, Lux, and Gerseny voted in favor, and the Chair declared the motion to have carried unanimously (5–0).
